## **Hollywood PAL Soccer Rules and Regulations**

## **Soccer Dues**

Annual dues for PAL are \$60 every six months, which includes a uniform, field fees, referee fees, and league registration fees. Please make checks or money orders only (no cash) payable to **Hollywood PAL**. If you cannot afford the entire payment, please speak with the PAL officer in charge of the program.

#### **Rules and Regulations**

Soccer is a physical sport. During the course of training, your children will be asked to do many physical activities such as, but not limited to, running, sit-ups and push-ups. It is the responsibility of the parent and child to notify officers and coaches of any restraints on your child's ability to complete any of the exercises that they are asked to perform during practices and games. You and your children must agree to the following rules and regulations prior to participation in the PAL Soccer Program and any programs affiliated with PAL. PAL participants must:

- Respect officers, instructors, and other participants at all times
- Respect the decisions and/or requests of coaches/chaperones and do their best to listen and learn
- Wear the official PAL soccer uniform
- Not use profanity and/or engage in inappropriate behavior
- Understand that fighting or horseplay will not be tolerated under any circumstances
- Submit a copy of their updated report card in January and June of each year
- Must attend tutoring if they have a GPA lower than 2.0
- Not engage in any illegal or questionable activities
- Identify themselves as a Hollywood PAL participant if apprehended for any reason by law enforcement
- Participate in all practices, every week (M/W or T/TH). If a player is unable to do so, they may be subject to removal from the soccer program or moved to a wait list.
- Understand that not abiding by Hollywood PAL's Participant Code of Conduct will cause disciplinary action, which may include removal from the program or program events
