SIGNATURES

In consideration of the acceptance of my child in the educational programs of the Police Activities League (PAL), the undersigned parent (s)/legal guardian (s) of the Student consent to the participation of the Student in PAL activities and programs and release PAL from any liability, damage or loss that may be associated with or which may arise out of the student's participation therein, as follows:

1. Consent

A. PAL Activities and Special Events: (1) The day-to-day activities of PAL, which are part of the student's curriculum, and (2) Special events at, or concerning, PAL. "Special Events" shall mean all other scheduled events or projects that are not necessarily part of the Student's general activities, or which do not fall within the categories of sports activities or field trips.

B. Sports: This consent applies to the Student's involvement in such sporting activities, whether as an active participant in the sport or not, or as a spectator, and this consent further extends to travel to and from the location of such sporting activities.

C. Field Trips: Field trips associated with, or arranged by PAL. For purposes hereof, "field trips," outings or visits to locations other than any of the PAL locations for educational, cultural, social, political or other beneficial purposes, including but not limited to museums, historical sites, concerts, and other educational facilities, factories or other industrial facilities, banks or corporations and other commercial enterprises, and more. I also give full authorization for my child to participate in all field trips that are a part of the planned activities and program of PAL.

2. Release

A. Special Claims: The undersigned release (s) PAL, its affiliates, officers, directors, shareholders, employees, attorneys, agents, representatives, predecessors, successors and assigns and all others acting by, through or under same, from any liabilities, damage or loss that may occur due to or arising out of the matters described in Section 1 above, regardless of whether such damage or loss is the nature of a personal injury, happening to the Student, or happening to another caused by the Student, or as property damage, regardless of whatever extent or degree.

B. Medical Release: In the event that my child becomes ill or sustains an injury while in the care of PAL, I understand that every effort will be made to contact the parent (s) or legal guardian (s). If it is not possible to reach me or the physician named above to receive instructions for his/her care, consent is given to any licensed physician and/or surgeon called for or to whom the child is taken for treatment by them, to administer drugs or medicines and to perform such surgical procedures as he shall think the existing emergency requires for the relief of pain and to preserve his/her life and health.

C. Photo Release: Due to the non-profit nature of the PAL program, I understand that photos, artwork or video of children may be used for promotional purposes, whether in written, electronic (website) or other forms. I thereby give my consent to use photos of my child for this limited purpose. Furthermore, I hereby consent that such information, photographs, videos, and/or tapes from which they are made shall be PAL property, and PAL shall have the right to sell, duplicate, reproduce and make other uses of such information, photographs, videos, and recordings as they may desire free and clear of any claim whatsoever on my part.

I/We have carefully read this consent and release agreement and have given PAL the correct information on the front of this form. I/We agree to update this information as needed and fully understand its contents. I am aware that this is a release of liability, including any claims not now known to me, and that it is a contract between myself and the Police Activities League Program, and/or its affiliated organizations, and I/We sign the document voluntarily.

Hollywood PAL Fees & Rules and Regulations

1. Martial Arts Dues

The cost for new students to register for PAL is \$50, which includes a uniform, belt, and the first month's dues. Martial arts dues are \$20 per month, plus \$5 for each additional child. Fees should be paid with a check or money order payable to Hollywood PAL.

2. Soccer Dues

Seasonal dues for PAL are \$75 every six months, which includes a uniform, field fees, referee fees, and league registration fees. Please make checks or money orders only (no cash) payable to **Hollywood PAL**.

3. PAL Regulations

Martial Arts and Soccer are a physical sport. During the course of training, your child will be asked to do many physical activities such as, but not limited to, running, sit-ups and push-ups. It is the responsibility of the parent and child to notify officers and coaches of any restraints on your child's ability to complete any of the exercises that they are asked to perform during classes. If your child is continually unable to perform physical activities, they may be asked to leave the program. You and your children must agree to the following rules and regulations prior to participation in the PAL Martial Arts, Soccer program, and any other programs affiliated with PAL. PAL participants must:

- **Respect officers, instructors, and other participants at all times**
- **Respect the decisions and/or requests of coaches/chaperones and do their best to listen and learn**
- **Wear the official PAL martial arts uniform**
- **Not use profanity and/or engage in inappropriate behavior**
- **Understand that fighting or horseplay will not be tolerated under any circumstances**
- **Eat and hydrate themselves prior to arrival at the studio or the soccer field**
- **Keep noise to a minimum while inside the studio and while on the field**
- **Understand that while inside the martial arts studio, there will be no cell phone usage, eating or gum chewing**
- **Not engage in any illegal or questionable activities**
- **Identify themselves as a Hollywood PAL participant if apprehended for any reason by law enforcement**
- **Submit a copy of their updated report card in January and June of each year**
- **Must attend tutoring if they have a GPA lower than 2.0**
- **Commit to attending at least 2 practices each week. If a student is unable to make this commitment on a consistent basis, they may be asked to leave the program.**
- **Understand that not abiding by Hollywood PAL's Participant Code of Conduct will cause disciplinary action, which may include removal from the program or program events**
